After getting affiliation with CBSE Delhi, the School Management will be bound to implement pay scales and allowance to the teaching & non teaching staff at par with their counterparts working under the Punjab Govt. and to pay salary through payees A/C. in case of any violation in this respect the NOC would be withdrawn.
5. You and your Management will ensure in case of any information called for by the DEO or any senior officer of the Education Department is made available and the suitable co-operation will also be the extended to the concerned Officer.
